Mrs. Nanni had a map of Cary Cemetery that she wanted the Town to have back; Alan said the Historical Society should keep it and have it framed. Mrs. Nanni will look into the cost of framing.

Darlene Warner's new book is now available and 20 copies been sold to date.

Bob Ostrander, resident of Water District 4 asked the Town Board what the \$40 user fee was on his water bill. The Town told him that \$15 is for the water tower but the Town is unclear as what the other \$25 goes for; the Village has been asked many times but has not given a clear answer. Mr. Ostrander stated he is concerned that the money is going where it should.

Councilman Cianfrini told Mr. Ostrander that he should ask the Village where the money goes. Mr. Ostrander stated he has but has been told "that's just how it is" as an answer.

Mr. Ostrander also asked why the user fee hasn't decreased since more water users have been added. Again, the Town Board stated that they are aware of these issues and trying to get answers.

#### **DISASTER COORDINATOR**

Mr. Graham was not in attendance but left a proposal for a Cell Phone Booster at a cost \$899.99. Currently, we have low cell service within this building. Cell phones and radios don't work and this building was designed to be a disaster center should the need arise. The money for this booster in in General Fund A5132.4 Garage Contractual. (There is a 30 day guarantee on this product)

## Millennium Computers Web Registration, Hosting, Development 7 Maintenance Quote

A proposal to upgrade the website hosting program and develop and maintain the site was received by the Town Clerk. The Town currently pays \$20 annually for the DNS and \$240 annually for web hosting.

The proposal will keep the two charges above in place. A onetime Web Development charge of \$1,180 to upgrade what the Town currently has and an additional \$240 annually for Millennium to update our site regularly. The total cost for 2016 will be \$1,680.00, there after the cost will be \$500 per year.
